4.In view of the above, no further clarification is required in this matter and the order dated 10.07.2025 in W.P(MD)No.12689 of 2025 stands confirmed.

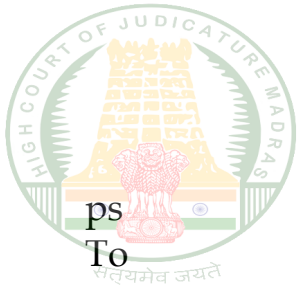
