2.With reference to the relief sought for in the present Writ Petition, the learned Government Pleader appearing for the respondents 1 to 4 submitted that the subject land has not been assigned in favour of any other person.

3.The learned counsel appearing for the petitioner submitted that the subject land has been earmarked for construction of a bus shelter.

4.May that as it be, it is for the authorities to take an appropriate administrative decision regarding the construction of a bus shelter by considering the needs of the people in that locality.
