4. The learned counsel appearing for the petitioner submitted that the regular work of the accused is affected and hence, the condition should be relaxed.

Considering the facts and circumstances of the case and also considering the fact that the petitioner needs to appear before the Court during any of the working days for complying the condition, this Court feels that it is appropriate to modify the condition imposed in Crl.M.P(MD).No.3285 of 2024 in Crl.A(MD).NO.226 of 2024, dated 23.10.2024. Accordingly, this Criminal Miscellaneous Petition is disposed of by modifying the condition by directing the petitioner to appear before the trial Court on the first working day of every month at 10.30 am., until further orders.
