The relief sought for in the present Writ Petition is to forbear the respondents 1 to 3 from dumping any garbage of waste materials in the public crematorium belonging to the 4th respondent Village Panchayat and to remove the illegal and unauthorized structures put up in the public crematorium by the 3rd respondent for waste dumping.

2.The learned counsel appearing for the petitioner would submit that the 3rd respondent is not dumping garbage on account of the interim order passed by this Court.
