The said application has been rejected by the second respondent by an order dated 20.01.2025. Aggrieved by the same, the petitioner preferred a revision before the first respondent on 17.02.2025 and the same was taken on file in Na.Ka.No. 3029593/2025/A6 on 24.02.2025. The same has not been considered till date. Therefore, the petitioner has come before this Court seeking the above mentioned prayer.

4. The learned Additional Government Pleader appearing for the respondents 1 to 4 would submit that the revision proceedings pending before the first respondent will be disposed of in accordance with law.

5. In view of the same, without expressing any opinion on the merits of the matter, the first respondent is directed to consider the revision pending on his file in Na.Ka.No. 3029593/2025/A6 and dispose of the same within a period of twelve (12) weeks from the date of receipt of a copy of this order, after issuing notice to the petitioner and the respondents 5 and 6.
