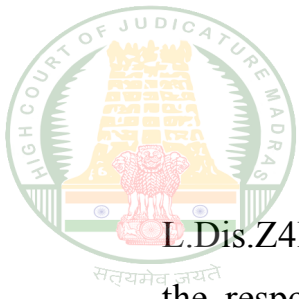

ORDER

The writ petition has been filed against the order of the third respondent, dated 15.09.2023 and to direct the respondent to cancel the excess house tax amount of Rs.25,396/- and transfer his name into the house tax.

2. The learned counsel for the petitioner submits that the petitioner has already filed an appeal against the impugned order before the tax appellate committee under Section 100 of the Tamil Nadu Urban Local Bodies Act. Therefore, he submits that a direction may be issued to the tax appellate authority to dispose of the appeal as expeditiously as possible.
