2.According to the petitioner, he sent a complaint to the respondent police against the 3rd respondent. Though CSR No.332/2025 has been registered, thereafter, the same has not been considered. Hence this petition.

3.The learned Additional Public Prosecutor appearing for the respondent police would submit that CSR No.332/2025 is under consideration with the second respondent and they will conduct enquiry and take appropriate action, in accordance with law.

4.Considering the limited scope of the prayer sought for in this petition, this Court, without even issuing notice to the private respondent, is inclined to pass orders.
