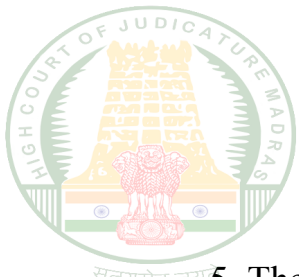

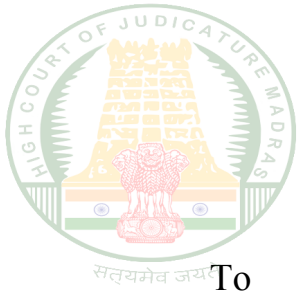
2. Recording the same, the writ petition stands disposed of. No costs. Consequently, connected miscellaneous petition is closed.
