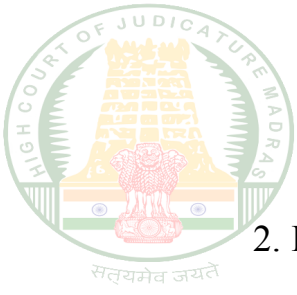

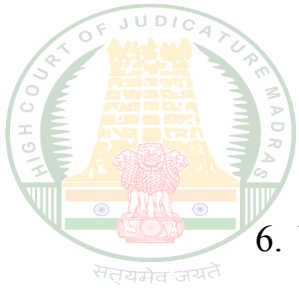
2. Heard the learned counsel for the petitioner and the learned Additional

In view of the above, this writ petition is disposed of, directing the 3rd respondent to call the petitioners individually for enquiry and after scrutinizing the documents submitted by the respective petitioners and ensuring that their pattas have not been already cancelled and to pass suitable further orders, within a period of sixteen (16) weeks from the date of receipt of copy of this order.
