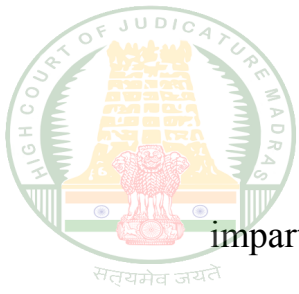

This Criminal Original Petition has been filed seeking a direction to the respondents 1 and 2 to transfer the inquiry of the petitioner's complaint dated 15.11.2021 pending on the file of the 3rd Respondent to any other independent and impartial investigation agency.

2.According to the petitioner, he sent the representation dated 15.11.2021 to the third respondent, but the same has not been considered. Hence this petition.

3.The learned Government Advocate (Crl.Side) appearing for the respondent police would submit that the petitioner's representation, dated
