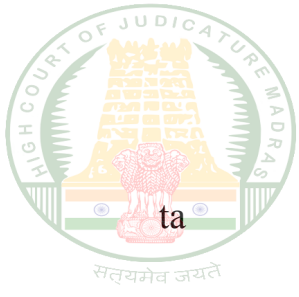
3.The petitioner is the plaintiff in O.S.No.27 of 2024 filed for declaring the marriage certificate issued by the third respondent herein as null and void.
