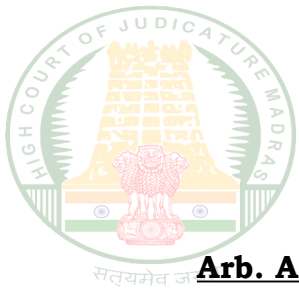

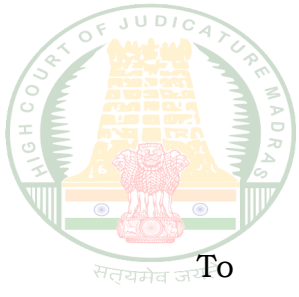
2.The prayer in the Arbitration Appeals have become infructuous since the issue is already settled.
