a civil dispute pending between the petitioner and the private respondents.

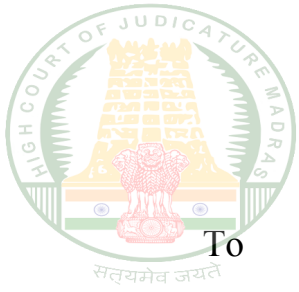
Therefore, the petitioner sent a representation dated 30.05.2024 to the second respondent, but the same has not been considered. Hence, he filed this petition.
