(Order of the Court was made by ***S.M.SUBRAMANIAM, J.***)

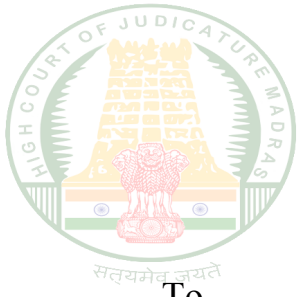
