This Contempt Petition has been filed to punish the respondent for willful disobedience of the order of this Court dated 15.12.2022 made in W.A.(MD)No.1226 of 2022, wherein this Court passed the following order:-

“6.In the light of the joint affidavit dated 29.11.2022 filed by the appellant as well as the fourth respondent, the order dated 16.06.2022 passed by the learned Judge in WP (MD) Nos. 6012 of 2018, 8137 of 2021 and 8145 of 2021 is modified. As mentioned in the affidavit dated 29.11.2022, the fourth respondent in WA (MD) No. 1226 of 2022 namely Mrs. S.K.A.Noorjahan Beevi shall submit the application seeking renewal of the permit for the Bus bearing Reg. No. TN-65-Y-9516 as well as replacement of the vehicle and on receipt of the same, the Regional Transport Authority, Sivagangai shall pass appropriate orders thereon. Upon renewal, the appellant along with his brother shall ply the vehicle in question and such right to ply the vehicle is subject to the outcome of the suit in O.S. No. 109 of 2013 pending on the file of learned District Munsif, Paramakudi. The affidavit dated 29.11.2022 filed by the appellant and fourth respondent shall form part of the records.

7.Accordingly, all the appeals are disposed of. No costs. Consequently, connected miscellaneous petitions are closed.”
