ORDER

The petitioners claim to be a purchaser of the lands in respect of which, survey has been directed by an order passed by me on 11.03.2025 in W.P(MD)No.6430 of 2025 at the instance of one Sivakamu Ammal.

2. Mr.N.Mohan, learned counsel appearing for the petitioner fairly submits that since the petitioner herein was not made a party, he has an objection with regard to the survey, however, would state that since survey has already been directed, under the guise of survey, there shall be no dispossession.

3. In view of the above, the writ petition is disposed of directing the respondents 1 & 2 to consider the objections of the petitioner at the time of survey being conducted pursuant to the order passed by me in
