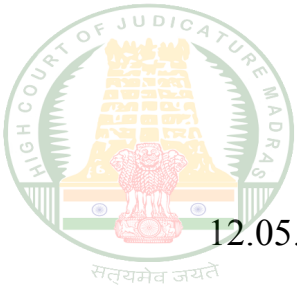

ORDER

This Writ Petition has been filed seeking a direction to the respondents to grant permission for Musical Kachery Program at Arulmigu Veppilai Mariamman Thirukovil, Manaparai, Trichy District on 07.05.2025.

2.When the matter is taken up for hearing, the learned Government Advocate (Crl.Side) appearing for the respondent police would submit that for the above said temple, six persons have filed writ petitions seeking permission for conducting the said programmes on different dates. Among them, for one of the persons, the respondent police has granted permission for conducting the programme.
