ORDER

This Criminal Original Petition has been filed to quash the proceedings pending in STC No.2495 of 2019 on the file of the Judicial Magistrate Court, Paramakudi

2. Based on the complaint given by the defacto complainant, the police has registered FIR in Crime No.101 of 2019 for the offences under Sections 147,294(b), 323 and 506(i) of IPC.

3. When the matter was taken up for hearing, the learned counsels on both sides represented that during pendency of the case, the matter has been amicably settled between the parties and to that effect, they have entered into a compromise and the same was filed before this Court.

4. Today, the defacto-complainant and the accused are present and the Court enquired about the terms of compromise. The defacto-complainant represented that they entered into a compromise. A compromise memo, dated 25.04.2025 signed by the parties and their respective counsels, is also filed before this Court.

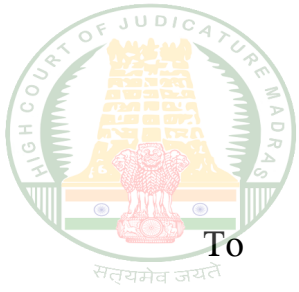
WEB COPY 5. This Court has perused the terms of the compromise memo.
