UNDER SECTION 528 OF THE BNSS Act, to relax the condition imposed in Crl.A(MD)No.365 of 2025, dated 26.03.2025.

PRAYER IN CRL.A.(MD)No.812 of 2022 :

Criminal Appeal filed under Section 14-A(2) of Schedule Caste and Schedule Tribes (Prevention of Atrocities) Amendment Act, 2015, as against the order of dismissal passed by the learned Judge, Special Court for Exclusive trial of cases under SC/ST (POA) Act, Thoothukudi (FAC) in Cr.MP.No.40 of 2025 in Crime No.270 of 2023, dated 06.03.2025.

However, it is made clear that the petitioner should not take advantage of this order and omit to appear for trial whenever the case is posted for trial.
