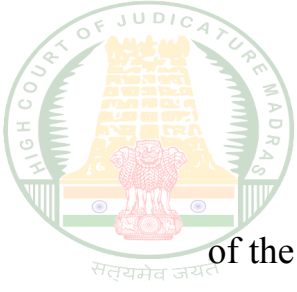

4. To the above extent, this Writ Petition is ordered. No costs. Consequently, connected Miscellaneous Petition is closed.

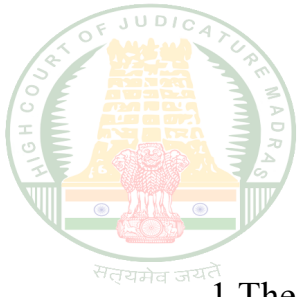
