2. The learned counsel for the petitioner submitted that the petitioner has been complying with the condition imposed by this court regularly and he prays for relaxation of the said condition.

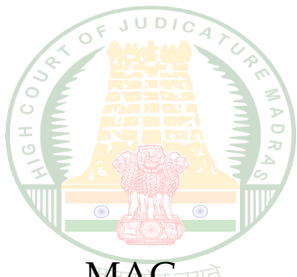
