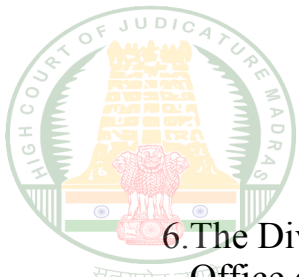

By consent of both parties, this Writ Petition is taken up for final disposal at the stage of admission itself.

2.Challenging the eviction notice dated 11.04.2025 issued by the 3<sup>rd</sup> respondent, the petitioner has filed this Writ Petition with a consequential direction to the 4<sup>th</sup> respondent to grant patta in favour of the petitioner based on the representation dated 19.04.2025.

3.The learned counsel appearing for the petitioner would submit that similarly placed persons were already granted alternative site and some of them granted patta. Therefore, the petitioner is also entitled for the same. She has also submitted a representation dated 19.04.2025, seeking patta in her favour and the same is pending till date without any progress.

4.In view of the said submission, since the similarly placed persons were granted alternative site or patta, the 4<sup>th</sup> respondent is directed to consider the said representation of the petitioner and pass appropriate orders, on merits and in accordance with law, within a period of twelve weeks from the date of receipt of a copy of this order. Till such time, the impugned eviction notice is kept in abeyance.

5.With the above direction, this Writ Petition is disposed of. No costs. Consequently, connected miscellaneous petition is closed.
