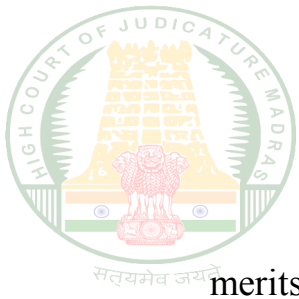

ORDER

The petitioner herein seeks a direction to the respondents to consider her representation dated 03.01.2025 seeking issuance of patta in her name.

2. It is the case of the petitioner that she claims right over the property to an extent of 228 Square feet with house in Survey No. 694A/2A1A1A1 under registered settlement deed dated 02.01.2009 executed by her husband namely Sadik Batsha. The petitioner submitted a representation before the respondents seeking issuance of patta in her name based on registered documents and parent documents and the same has not been considered. Hence, the petitioner is before this Court.

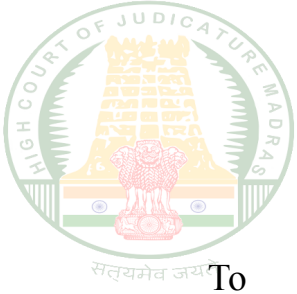
