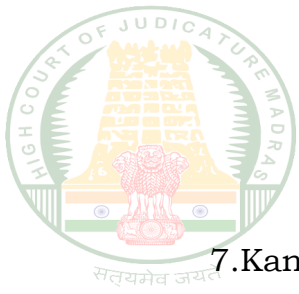

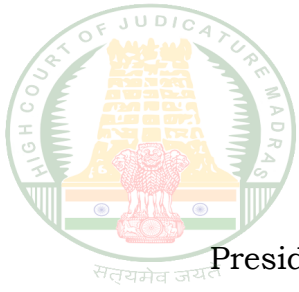
PRAYER: Writ Petition filed under Article 226 of the Constitution of India, praying this Court to issue a Writ of Mandamus, directing the official respondents to remove the sixth respondent from her Vice-President post as well as 3rd ward member of the 5th respondent by applying section 38 (e) of the Tamilnadu Panchayat Act, 1994 and consequently recover Rs.5,00,000/- from the 7th respondent for theft of Veli Karuvelam trees from the Petchipuram Tank, Arasinipatti and Arasaneri Keelamedu Village, Sivagangai Taluk and District, based on the petitioner's representation dated 23.09.2020 and the general public and farmers' representation dated 29.09.2020 within the period that may be stipulated by this Court.

President post as well as III ward member of the fifth respondent and consequently recover a sum of Rs.5,00,000/- from the seventh respondent for the theft of Veli Karuvelam trees from Petchipuram Tank, Arasinipatti and Arasaneri Keelamedu Village, Sivagangai Taluk and District.

2. The learned Government Pleader appearing on behalf of respondents 1 to 3 would submit that the tenure of the post of Vice President has already expired and nothing survives in this writ petition.

3. Recording the submission made by the learned Government Pleader, this Writ Petition is dismissed as infructuous. However, there shall be no order as to costs. Consequently, connected miscellaneous petition is closed.
