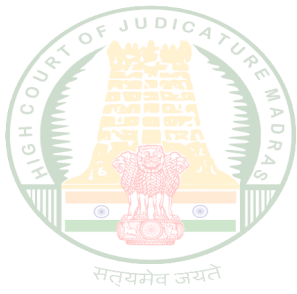

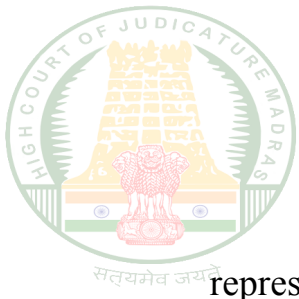

ORDER

The petitioner herein seeks a direction to the respondents to consider her representation dated 03.01.2025 seeking issuance of patta in her name.

2. It is the case of the petitioner that she claims right over the property to an extent of 306 Square feet with house in Survey No. 694A/2A1A1A1 under registered settlement deed dated 13.06.2007 executed by her father namely Mohammed Hussin. The petitioner submitted a representation before the respondents seeking issuance of patta in her name based on registered documents and parent documents and the same has not been considered. representation submitted by the petitioner will be considered on its own merits and in accordance with law within a time stipulated by this Court.

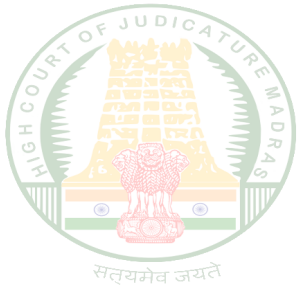
