3.The grievance of the petitioner is that his representations dated 07.10.2024 and 22.04.2025 seeking regular supply of electricity to the petitioner village, have not been considered so far. Therefore, he has filed this Writ Petition.

5.Considering the limited scope of the prayer sought for by the petitioner, without expressing any opinion on the merits of the claim made by the petitioner either in the representation or in the affidavit filed in support of the Writ Petition, this Writ Petition is **disposed of** with a direction to the third respondent to consider the representations of the petitioner dated 07.10.2024 and 22.04.2025 by giving an opportunity of hearing to the petitioner as well as the fourth respondent and pass appropriate orders on merits and in accordance with law within a period of twelve [12] weeks from the date of receipt of a copy of this order. No costs.
