Since no adverse orders are proposed to be passed at this stage, this Writ Petition is disposed of at the time of admission by directing the second respondent to consider and pass appropriate orders on the petitioner's representation, dated 12.04.2025 as expeditiously as possible considering the age of the petitioner. While passing the aforesaid order, the second respondent shall also take note of the decision of the Hon'ble Division Bench of this Court in ***S.Mala vs. District Arbitrator & District Collector, Nagapatinam District, Nagapatinam and others*** reported in ***2025 (2) CTC 373, [2025 MHC 706]***.

5. Needless to state, before passing any adverse order, due notice is also to be issued to the petitioner's son, against whom the petitioner filed the complaint.

6. This Writ Petition is disposed of, with above observations. No costs.
