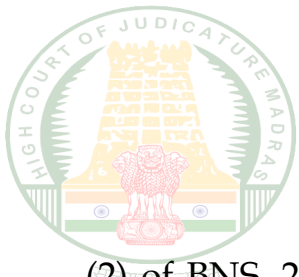
PETITION FOR ANTICIPATORY BAIL Under Sec.482 of BNSS, 2023
