JUDGMENT

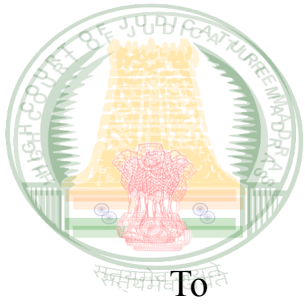
[Judgment of the Court was delivered by ***S.M.SUBRAMANIAM, J.***]
