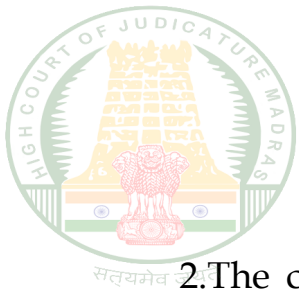
PETITION FOR BAIL Under Sec.483 BNSS, 2023

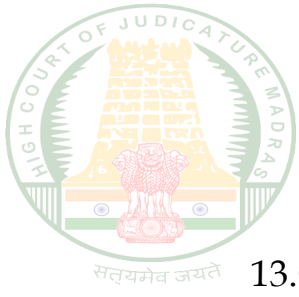
