ORDER

2. This Court vide order dated 14.05.2025, directed the respondent to disburse the advance amount mentioned in the order, dated 02.04.2025 passed in W.P(MD) No.6938 of 2025 to the petitioner on that day itself and posted the case on 15.05.2025.
