The Writ of Mandamus has been instituted to direct the respondent Nos. 1 to 4 to remove the encroachment by the respondent No.5 situated in survey No. 48/49, in Eluvani Group Rettaikulam Village, Thiruchuli Taluk, Virudhunagar District in accordance with law.

2. The learned Government Pleader appearing for the respondents 1 to 4, on instructions, would submit that survey was conducted and encroachments are identified and notice under Section 7 of the Land Encroachments Act are also

issued on 14.07.2025 and after affording an opportunity to the encroachers, final notice under Section 6 of the Land Encroachment Act was issued vide proceedings dated 31.07.2025.

3. That being the factum, the officials are directed to complete the enforcement action and remove the encroachment within a period of eight weeks from the date of receipt of a copy of this order.

4. With the above direction, the writ petition is disposed of. No costs.
