2.The grievance of the petitioner is that his representation dated, 24.02.2025, seeking necessary action and an enquiry against the encroacher/sixth respondent in Survey No.1096/36 (old Survey No.65/5A) of Veerasigamani Village, Sankarankovil Taluk, Tenkasi District, has been kept pending without any progress. Hence, the petitioner has filed this Writ Petition seeking the aforesaid relief.

3.The learned Special Government Pleader appearing for the respondents 1 to 4 submits that the representation of the petitioner will be considered and appropriate orders will be passed on its own merits within a time frame stipulated by this Court.

4.Considering the limited scope of the relief sought for by the petitioner and without expressing any opinion on the merits of the petitioner's claim either in the representation or in the affidavit filed in support of this Writ Petition, we direct the respondents 2 to 5 to consider the representation of the petitioner dated, 24.02.2025, after affording sufficient opportunity of personal hearing to the petitioner and the sixth respondent and pass appropriate orders on merits and in
