Municipality, Nilakkottai Taluk, Dindigul District with extent about 18 acres, has been kept pending without any progress. Hence, the petitioner has filed this Writ Petition seeking the aforesaid relief.

3.The learned Additional Government Pleader appearing for respondents 1 to 9 submits that the representation of the petitioner will be considered and appropriate orders will be passed on its own merits within a time frame stipulated by this Court.

4.Considering the limited scope of the relief sought for by the petitioner and without expressing any opinion on the merits of the petitioner's claim either in the representation or in the affidavit filed in support of this Writ Petition, we direct the respondents 3 to 8 to consider the representation of the petitioner dated 30.04.2025, after affording sufficient opportunity of personal hearing to the petitioner and the respondents 10 and 11 and pass appropriate orders on merits and in accordance with law within a period of **twelve (12)** weeks from the date of receipt of a copy of this order.
