ORDER

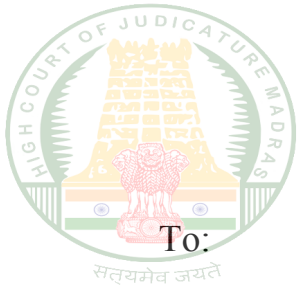
[Order of the Court was made by **A.D.JAGADISH CHANDIRA, J.**]
