2. Heard, the learned Counsels on either sides and carefully perused the materials available on record.

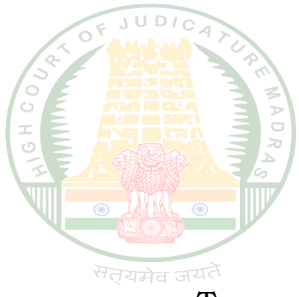
