When the matter is taken up for hearing today, the learned Additional Public Prosecutor appearing for the respondents, on instructions, submitted that the representation of the petitioner was already considered by the Prison Authorities vide order dated 10.06.2025 in No.384/உ.த.2/2025 and the petitioner has been granted ordinary leave for a period of 21 days with escort, since the life convict is going for the first time.
