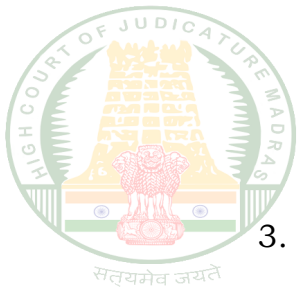

4. Heard the learned counsels on either sides and carefully perused the entire materials available on record.

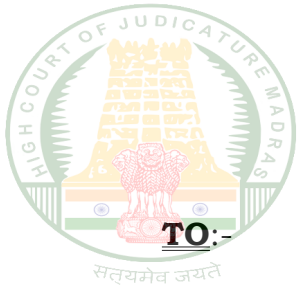
