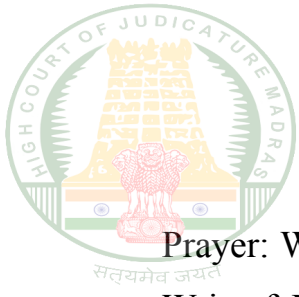

Mariappan as the one among the members of the festival committee who hails from Panikkan Clan towards peaceful celebration of the above mentioned temple festival as scheduled. The memo may be recorded and pass suitable orders for celebration of the temples festival as scheduled.

This Hon'ble Court may be pleased record the same and permit to celebrate the temples festival jointly as scheduled and thus render Justice.”

3.In view of the Joint memo filed by the parties, these Writ Petitions are hereby closed. There shall be no order as to costs. Consequently, connected miscellaneous petition is closed.
