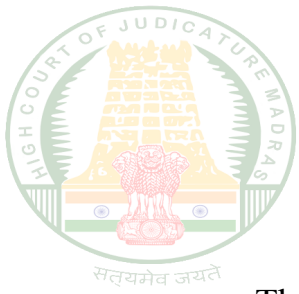

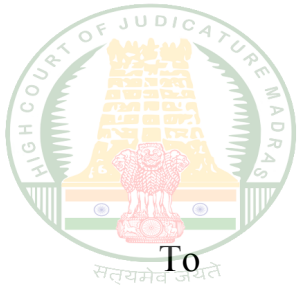
2.Since no adverse order is going to be passed as against the respondents, notice to the respondents is dispensed with.
