Heard both sides.

2.The writ petitioner is a practising lawyer. He was the standing counsel for the respondent corporation. Claiming that the fee dues payable to him had not been settled, this writ petition came to be filed.

By signing this Agreement the Parties hereto state that they have no further claims or demands against each other with respect to W.P(MD)No.15146 of 2025 and all disputes and difference in this regard have been amicably settled by the parties hereto through the process of conciliation / Mediation.”

4.The writ petitioner has signed the same. Therefore, the matter has to be given a quietus. The petitioner cannot be permitted to make any contra submission that his dues are yet to be settled.

5.This Writ Petition is disposed of accordingly. No costs. Consequently, connected miscellaneous petition is closed.
