ORDER

This writ petition has been filed seeking a writ of mandamus directing the respondents to settle the interest at the rate of 6 % for the belated payment of retirement benefits, Gratuity, Provident Fund, Leave Salary and Commutation.

2. Heard the learned counsel for the petitioner and the learned Standing Counsel, appearing on behalf of the respondents 1 and 2. By consent of both parties, the writ petition is taken up for final disposal at the admission stage itself.

3. The petitioner was appointed as a Conductor in the respondent Corporation on 21.02.1994 and he retired from service on 30.06.2023. The learned counsel for the petitioner submits that the petitioner's terminal benefits was not settled immediately and there is an abnormal delay.

4. In view of the same, the only issue to be considered in this writ petition is with regard to interest payable on the belated settlement. This issue was dealt with by this Court on various occasions and this Court

passed orders in several Writ Petitions. In fact, the issue involved in this writ petition is no longer *res-integra*.

5. This Court in W.P(MD)No.4866 of 2023 (***C.Murugan Vs. the Tamil Nadu State Transport Corporation (Tirunelveli) Ltd., and Another***) by order dated 07.03.2023 has decided this issue.

6. Accordingly, by following the order stated supra, this writ petition is allowed with the following direction:

The respondents shall pay interest to the petitioner at the rate of 6% per annum on the belated payment of the retirement benefits commencing from the date of retirement, till date of actual disbursement, within a period of three months from the date of receipt of a copy of this order. No costs.
