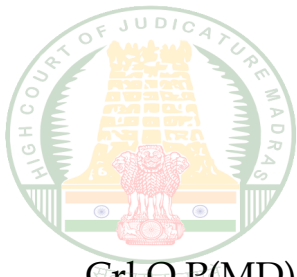
PETITION FOR RELAXATION Under Section 528 of BNS, 2023

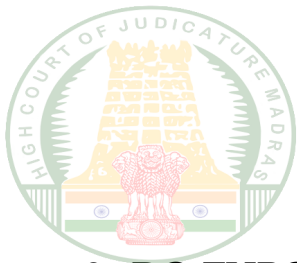
