2. The learned counsel appearing for the petitioner would submit that subject encroachments had already been removed.



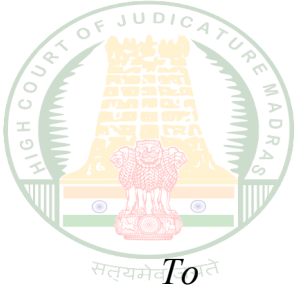
