Considering the rival submission and that there are two rival groups, this Court, by an order dated 02.06.2025, directed the Inspector of Hindi Religious Endowment Department to conduct the festival with certain conditions.

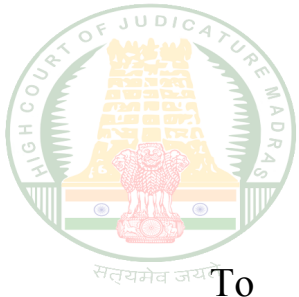
