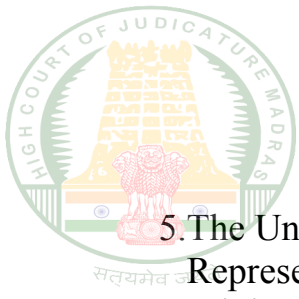

3. Accordingly, this Writ Petition is dismissed as withdrawn.

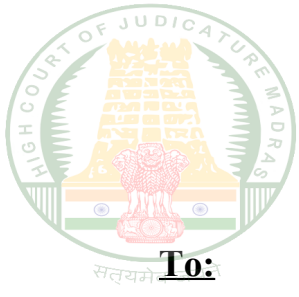

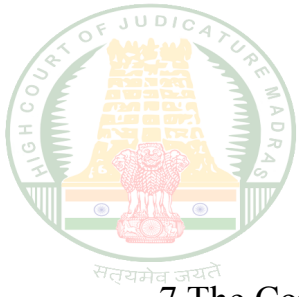
