To relax the condition imposed by this Court in Crl.O.P.(MD) No.5549 of 2025 dated 26.03.2025 on the file of this Court.

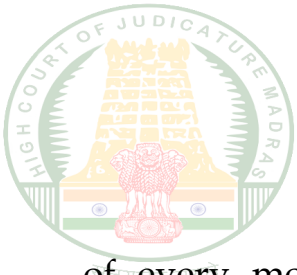
ORDER : The Court Made the following order :-
