offence under Section 302 r/w 109 of IPC and sentenced to Life Imprisonment. The

petitioner is in incarceration since 19.02.2024.

3. We are satisfied that the petitioner has arguable case on merits in the main appeal. Since the appeal is not likely to be taken up in the near future, we are inclined to grant suspension of sentence.

4. Accordingly, this Criminal Miscellaneous Petition is ordered and the imprisonment ordered by the trial Court through the impugned judgment, dated 19.02.2024 is suspended subject to the following conditions:-

i. The petitioner / A3 is directed to be enlarged on bail on executing a bond for Rs.25,000/- (Rupees twenty five thousand only), with two sureties, of whom, one should be a blood relative, each for a like sum to the satisfaction of the learned III Additional District and Sessions Court, Tirunelveli District.

ii. The sureties shall affix their photographs and Left Thumb Impression in the surety bond and the Court may obtain a copy of their Aadhar card or Bank passbook to ensure their identity.

iii. The petitioner shall report before the learned III Additional District and Sessions Court, Tirunelveli District, in the first working day of every English calendar month at 10.30 a.m., until further orders and if he is not able to appear before the trial Court on any day, he shall make arrangements to file an application under Section

317 Cr.P.C. and shall appear before the trial Court on any other day in lieu of the date
