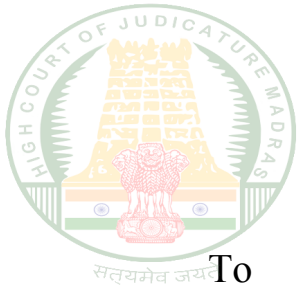
6.In view of the above, this Criminal Original Petition is closed as no further order is required to be passed. Consequently, connected Miscellaneous Petition is also closed.
