4. It is made clear that no further extension of time will be granted.

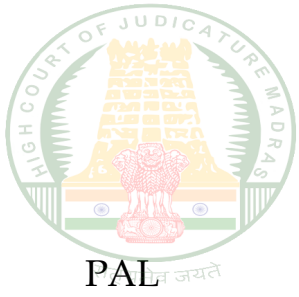
5. Accordingly, this Criminal Miscellaneous Petition is allowed.
